



Non-Profit/Community Application Saturday Farmers' Market Table 2022

The guidelines for the market are as follows:

- Set up and take down time: Merchants should arrive for set up at 8am, no later than 8:30am. Take down can begin after the market ends at 1pm.
- Location: **Please check in with Michael Peterson, Manager of the Farmers' Market before set up. He usually is in or near the information booth, which is by 55 W. Angela Street.**
- Space: The space is typically 10' x 10' but exact dimensions are determined by the operators of Farmers Market. **Merchant is responsible for bringing tent, chairs and a 6' table or less.**
- Attendance: On average during peak season, the market can get more than 5000 customers each Saturday. However, during the winter season, average is 2000-2500.
- Fee: per week \$100.00
- You can promote and market your business with informational pieces.
- You are permitted to sell only what you sell within your business.
- No alcohol or tobacco products permitted.
- Goods or services for sale must NOT be agricultural, consumable or in competition with other Farmers Market vendors.
- The PDA and Pacific Coast Farmers Market Association have the right to restrict the sale of any items/products in competition with market vendors or any items deemed inappropriate.
- Masks must be worn at all times during the market and all social distancing guidelines must be followed.

Market is open rain or shine from 9am – 1pm. There are no cancellations, refunds or changing of dates.

To reserve a date, please complete and return the below form along with the appropriate fee in the form of exact cash or check payable to the PDA. Dates will be assigned on a first-come, first-serve basis once payment is received. (Once a month max)
